Title: Tempeh Nuggets Provision Improves Energy Adequacy and Protein Intake in

Underweight Underfive Children

Conflict of Interest: There is no conflict of interest

Does the paper meet a high standard of scientific quality and credibility?

In this paper, research questions are clear. Research design is suitable to answer the questions. However, regarding the criteria measurements, it is not clear why nutritional content of Tempeh flour have been compared to those in Tempeh nugget. As it was mentioned in the manuscript, 27% of the nugget is Tempeh flour and therefore, the nutritional content should be lower in nugget than flour.

In discussion, in the first paragraph, it has been mentioned to "palm oil". It seems that nutritional content of palm oil needs to be considered in nutritional content of nugget earlier. Palm oil can affect considerably the energy intake of subjects as a main measurement criteria.

Is the paper readable and appropriately presented?

There is a good flow in this manuscript making it easy to read. However, there is not consistency in how the results are presented. As it is clear in the abstract and the result section for lipid percentage.

It is required to mention that how the data has been expressed: Mean ± SEM or SD

English language level: is the English language comprehensive and flawless?

This article needs an English language editing. There are a lot of grammatical and dictation mistakes, as well as inconsistency in using the same word such as tempeh (tempe) and Kcal (kkal).
