Review 1:

For instance, the introduction could be more focused and concise, highlighting the research objectives, questions, and the significance of the study. The literature review section could be better integrated with the introduction, providing a more comprehensive background and theoretical framework for the study.

In terms of the research methodology, while the qualitative approach and in-depth interviews are appropriate for this study, I recommend providing more details on the data collection and analysis processes. For example, how were the respondents selected? What was the rationale behind the choice of specific interviewees? How were the interviews conducted (e.g., semi-structured, openended questions)? Additionally, it would be helpful to clarify the data analysis techniques employed, such as coding and thematic analysis, to ensure the transparency and reliability of the findings.

As for the data analysis and discussion, I commend the author's efforts in identifying the key characteristics and indicators of each SC wave model. However, the analysis could be further strengthened by providing more specific examples and quotes from the interviews to support the arguments. Moreover, the discussion section could benefit from a more critical engagement with the existing literature, highlighting the contributions and implications of the study in relation to previous research on SC evolution and digital platforms.

Overall, I believe that addressing these structural, methodological, and analytical aspects would enhance the quality and impact of the article, making it a valuable contribution to the field of sustainable urban development and SC research.

Review 2:

Abstract:

The abstract could be more concise and better structured, following the standard format of research objectives, methods, key findings, and conclusions. The author should ensure that the abstract accurately reflects the content of the article and highlights its significance in the context of sustainable urban development.

Introduction:

The introduction provides a good overview of the SC concept and its evolution, but it could be more focused and coherent. The author should clearly state the research objectives and questions earlier in the introduction and explain the significance of the study in relation to the existing literature. Additionally, the theoretical framework and key concepts, such as the role of digital platforms in shaping the SC agenda, should be introduced more systematically.

Literature Review:

While the literature review touches upon relevant topics, such as the influence of IT giants and the contextualization of SC initiatives, it could be more comprehensive and critical. The author should

engage with more recent and high-impact studies on SC evolution and digital platforms, such as those by Komninos et al. (2019) and Karvonen et al. (2020). The review should also identify research gaps and clarify how this study contributes to addressing them.

Methodology:

The methodology section would benefit from a more detailed explanation of the data collection and analysis processes. The author should justify the selection of respondents and provide more information on the interview protocol and data analysis techniques employed. It is crucial to ensure the transparency and replicability of the research methods to meet the standards of international academic journals.

Discussion:

The discussion section should be reorganized to present the findings more systematically and engage more critically with the existing literature. The author should interpret the results in light of previous studies on SC evolution and digital platforms, such as those by Kitchin (2015) and Leszczynski (2020). It is also essential to discuss the limitations of the study and propose future research directions.

Conclusion:

The conclusion should be more concise and focused on the main findings and their implications for sustainable urban development. The author should also address the research questions posed in the introduction and highlight the study's contribution to the field of SC research.

Decision:

Based on the above comments, I recommend a decision of "major revisions." While the article addresses a relevant and important topic within the theme of sustainable development, it requires significant improvements in structure, methodology, data analysis, and engagement with the literature. The author should carefully address the reviewers' comments and revise the manuscript accordingly to enhance its quality and potential for publication in an international academic journal.
